Experience alone does not protect.


# Why this matters?



The licence is not an option. Insurance and compliance risks exposure are real.

Across Queensland, Employers require a site supervisor licence as part of recruitment. Furthermore, projects are audited more closely.

Without the right licence class:



You cannot legally supervise work



You limit your career options



You expose your employer to risk

**This is about authority, not paperwork.**

# The Licence Class Trap



This is where people get caught out. Holding a licence is not enough and not all site supervisor licences are the same.

**You must hold the correct licence class for the work you supervise.** Supervising outside your licence scope puts you, your employer and the project at risk.



## Site Supervisor - Low Rise

- ✓ Building work on **Class 1 or Class 10 buildings**
- ✓ **Building work on Classes 2 to 9 buildings** with a gross floor area up to 2000m<sup>2</sup>, provided it's not Type A or Type B construction.
- ✓ Non-structural building work on any building, regardless of class or size.
- ✓ Preparing plans and specifications for your own use, or for building work you are personally performing.



## Site Supervisor - Medium Rise

- ✓ Building work on **Class 1 or Class 10 buildings**
- ✓ Buildings up to **three storeys** in **Classes 2 to 9** excluding Type A construction.
- ✓ Non-structural building work on any building, regardless of class or size.
- ✓ Preparing plans and specifications for your own use, or for building work you are personally performing.



## Site Supervisor - Open

- ✓ Building work on **all classes of buildings**
- ✓ Preparing plans and specifications for your own use, or for building work you are personally performing.
